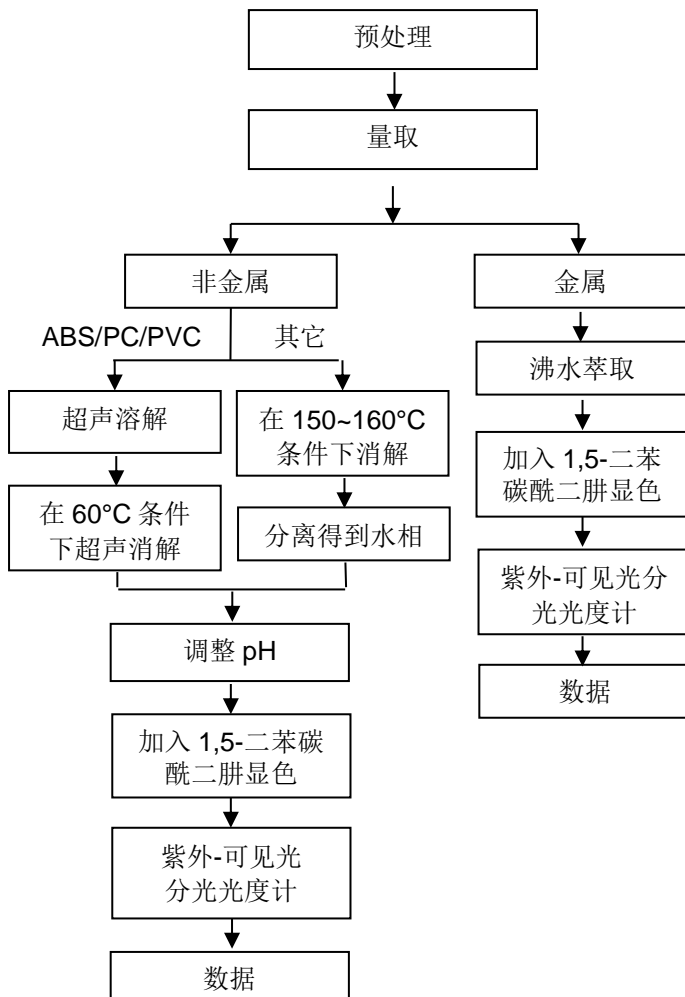

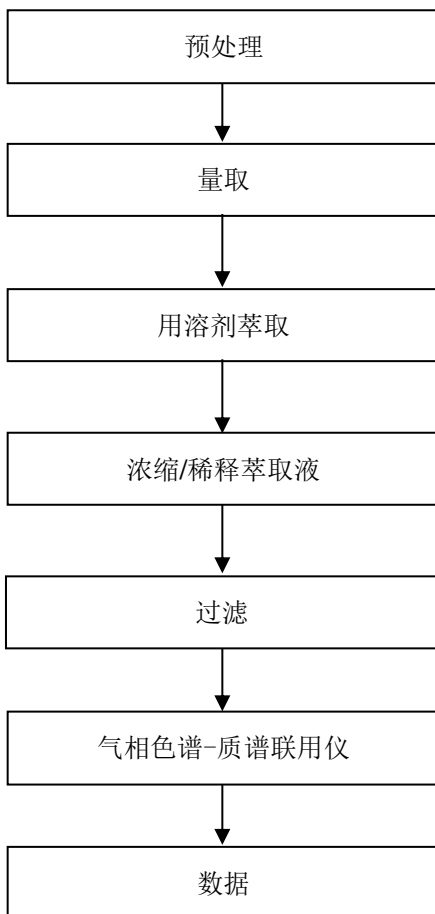

### PBB/PBDE 检测流程图



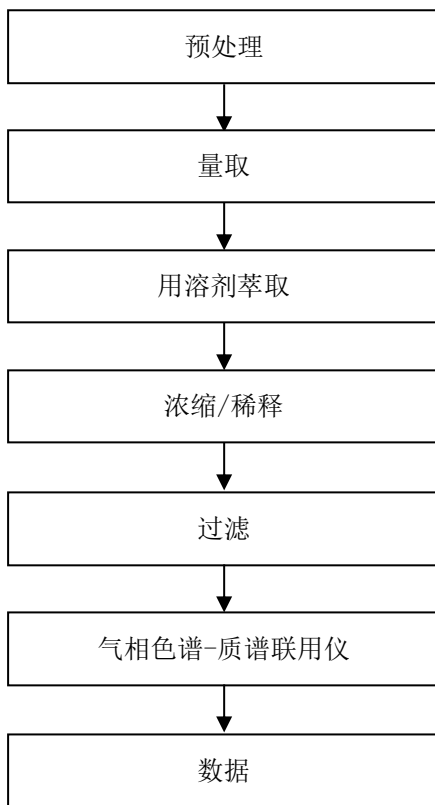

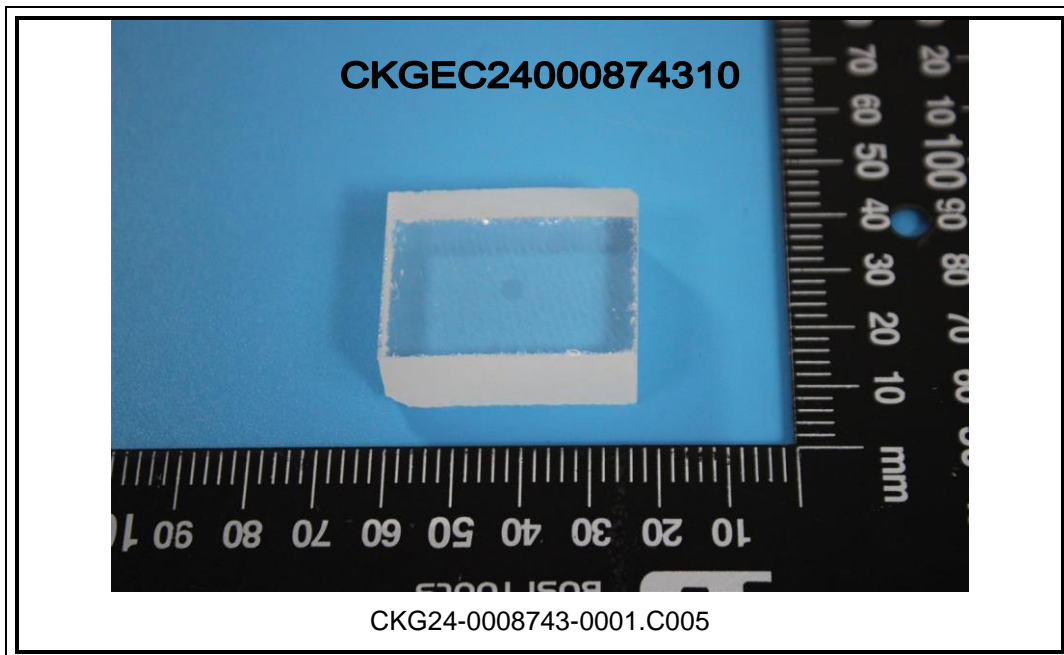
