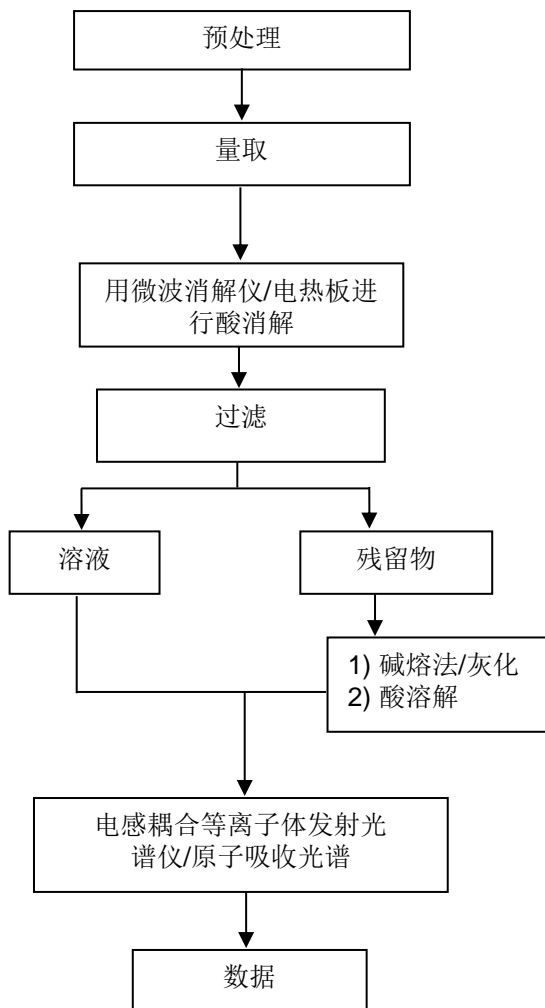

元素检测流程图

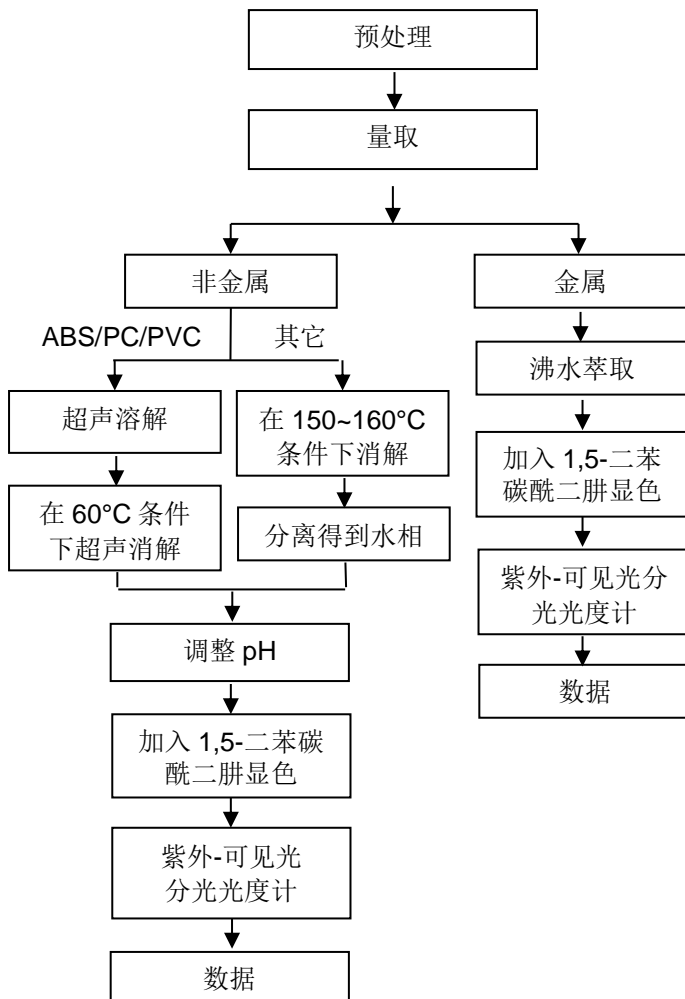

六价铬检测流程图



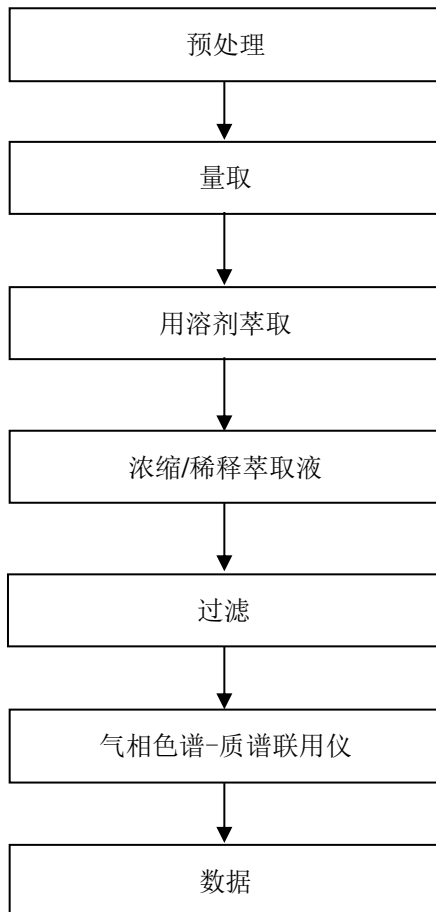

PBB/PBDE 检测流程图



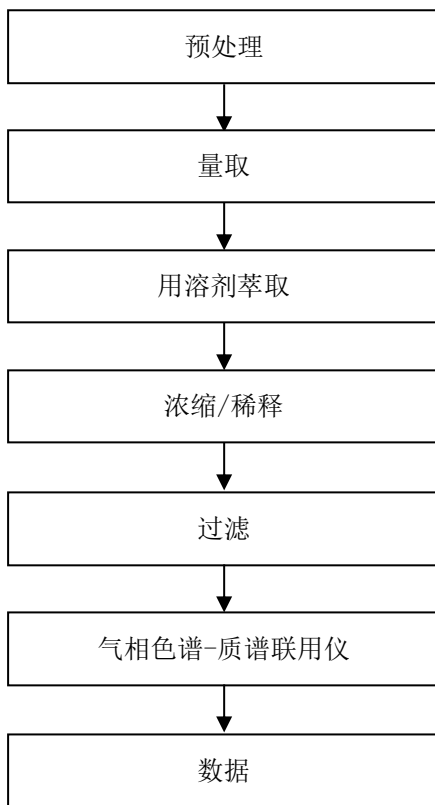

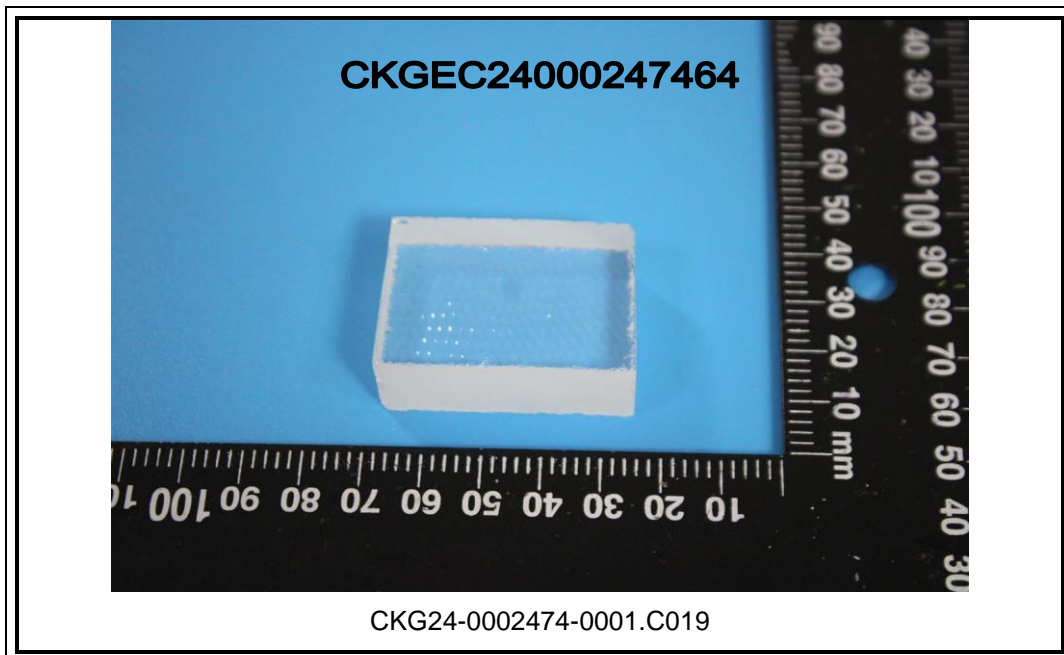
